**RE: Adoption of SLIP+ for Reporting and Payment of Surplus Line Taxes -
UPDATE**

Effective January 1, 2026, the Alabama Department of Insurance has adopted the **SLIP+ for States** <https://slipplus.com/> platform for the reporting and payment of Alabama surplus line policy data and taxes in accordance with §27-10-31 of the Alabama Code. View **Bulletin 2025-06** at <https://aldoi.gov/pdf/legal/Bulletin%202025-06.pdf>.

Surplus Line (Unauthorized) Insurance Companies are required to report all policy data on policies, **effective on or after January 1, 2026**, to the Alabama Department of Insurance using the **SLIP+ for States** platform <https://slipplus.com/>. Insurers are to submit policy data quarterly in accordance with the **SLIP+ for States** reporting schedule outlined below and at <https://slipplus.com/>.

Policy data for policies effective **prior to** January 1, 2026, is to be reported to the Alabama Department of Insurance using the legacy platform as currently submitted at <https://aldoi.gov/>.

The **Annual Audit and Examination Statement (Form PR)** shall continue to be filed along with remittance of payment via NAIC OPTins at <http://www.optins.org/>.
